

Rules & Regulations

1. **Exhibitors** may not assign, sublet or share their space; interfere with other exhibitors; use common space for storage or exhibits. No sharing of space will be allowed which includes signage or representatives of other companies that may assist in decorating and/or providing material for the booth unless all exhibitors involved have individual booths rented.
2. **Limit on Booths** - Although there is no advance limit on the number of booths a participant may purchase, the Show Committee has the right to limit the number of booths if demands so require.
3. **Right to Modify** - KABA reserves the right to refuse to sell exhibit space and to bar, move, modify exhibits, or portions thereof, which in the discretion of KABA are deemed objectionable or in poor taste. Exhibitor agrees to make changes as directed by KABA as soon as notified. Failure to do so will result in the removal of the exhibit, or portions thereof, by KABA. Any costs, incurred will be at the expense of the exhibitor. KABA reserves the right to change the layout of any booths, at any time, as may be deemed necessary.
4. **Signs** - all booths must be clearly identified with the company name. The sign provided by KABA must be used unless you provide your own company sign. Signs must be professionally made. No sign may be placed outside the booth area, in doorways, hallways or aisles.
5. **Exhibitors** agree to indemnify, and save harmless, KABA, the Buffalo County Fairgrounds from suit or claim for personal injury or property damage or for loss of use of property by whomsoever sustained.
6. **Exhibitors** are responsible for any damage or claim of damage to the Expo Building or any other exhibit or exhibitor arising directly or indirectly from use of their booth, including clean-up repair or cost of defending a claim for damage.
7. **KABA** is not responsible for inclement weather and does not guarantee the attendance.
8. **Exhibitors** are responsible for adequate liability insurance coverage on their booth contents. KABA, Buffalo County Fairgrounds are not responsible for any loss or damages. Security guards will be on site during closed hours.
9. **Door Prizes** - Exhibitors are encouraged to give away door prizes during public admission days but are not required to do so. Door prizes must be free of any obligation on the part of the winner. Raffles that require show attendees to be present at a specific location at a specific time are not permitted. All door prizes must be drawn prior to the close of the Show on Sunday.
10. **Exhibitor** agrees to abide by decisions, rules and regulations of KABA which may from time to time be formulated, and in the event of any misunderstandings, agree to accept the decision of KABA as final.
11. **Any piece of machinery** on display that has movable parts must have adequate safeguards to protect the public from injury.
12. **The Exhibitor** must comply with and be bound by all laws, ordinances and regulations of the City of Kearney, State of Nebraska, and Buffalo County, and wherever applicable, of the police and fire departments having jurisdiction. Fire exits and alleys must be kept open.
13. **Demonstrations** and all other activities must be confined to the limits of the exhibitor's booth. No merchandise or display equipment shall be shown outside the contracted space.
14. **There will be a \$5.00 admission** fee for adults. Children 12 and under will be admitted free.
15. **Booth Inspections** - KABA reserves the right to make an inspection of each booth prior to the opening of the Show.

Emergencies & Complaints

In the event of a medical emergency, you should proceed directly to the Home Show Service Office located in the southeast corner of the Expo Building. Appropriate authorities will be contacted immediately. Complaints, either by an exhibitor or attendee of the Show, should be directed to the Service Office. Although KABA and the Buffalo County Fairgrounds are not responsible for lost or stolen items from any booth, the Service Desk should be contacted immediately in the event items are missing from your exhibit in order that the appropriate authorities can be notified.
